Terms and conditions:

- 1. All bids must be submitted in a sealed envelope marked as "Quotation for Air Ticket" to the Director, BCAA, on or before 17th June 2024 before 02:00 p.m. and will open on the same day at 02:30 pm.
- 2. The rate should be quoted as per the sector given above and will be selected for the **most** economical route.
- 3. Tender document should contain a copy of **valid trade license**, **Tax clearance certificate** and lump sum amount of **Nu. 10,000/-** only as earnest money deposited in the form of draft/cheque/cash warrant issued in favour of the Director, BCAA.
- 4. The earnest money of Nu. 10,000.00 of the lowest evaluated bidder shall be retained with BCAA as performance security deposit and will be returned only after the delivery of the air tickets mentioned in the supply order for the above sector.
- 5. Airline and seats must be confirmed while submitting the quotation and submit confirmed itineraries.
