- Certified true copy of the passport.
- Certified true copy of the valid foreign AME licence.
- Evidence of type training. (Part-147 CofR)
- Evidence of training on human factors. (Part-147 CofR or Part-145 training)
- Evidence of training on Safety Management System. (Part-145 training)
- Evidence of passing BCAA Airworthiness Regulation Exam (Written and Oral).
- Evidence of exercising the privileges of the foreign AME licence (min 3 years).
- Evidence of need and justification for the validation by nominated postholder (maintenance/quality).
- Recent passport size photograph (45mm x 35mm).
- Copy of the payment receipt.

For the renewal of the certificate, the following supporting documents needs to be submitted;

- Certified True Copy of the valid Foreign AME licence.
- Copy of the payment receipt.
- Recent passport size photograph (45mm x 35mm).

5. Applicant Declaration
