 - b) procure the export and physical transfer of the aircraft from the Bhutan; and
- ii. confirmation that the authorised party may take the action specified in clause (i) above on written demand without the consent of the undersigned and that, upon such demand, the BCAA shall co-operate with the authorised party with a view to the speedy completion of such action.

The rights in favour of the authorised party established by this instrument may not be revoked by the undersigned without the written consent of the authorised party.
